- Upcoming Technical Enhancements
 Dataset capture Being able to customize and capture multiple sets of data in a single set. For example, easily collect a survey at 3 ft, a survey at 3 inches, an air sample and an observation in one set. Will save time and energy for field teams.
- The one-stop-shop Looking to make RadResponder a single location for additional rad/nuc resources, documents and tools for the community. Without impacting the discoverability or the utility of its primary functions.

CRCPD Update for FRMAC Call

- The National Conference on Radiation Control will be held in Scottsdale, Arizona, May 711, 2017. Several presentations will be focused on homeland security and emergency
 response topics. In addition, an 8-hour training course will be held on Sunday, May 7,
 entitled "Advanced Rad/Nuc Emergency Training and Live Source Field Exercise," using
 the most recent research and guidance on radiological and nuclear emergency
 response.
- The CRCPD's Task Force on Radiation Volunteer Development will be holding an expanded meeting in Atlanta during the week of February 4, 2017 in Atlanta. For the past 5 years, the Task Force and the Executive Office have approved state and local radiation control and public health preparedness programs to recruit and train radiation professionals as volunteers through the Medical Reserve Corps and similar programs to assist in population monitoring in the case of a major radiological incident. Several of the sub-awardees have been invited to the meeting. The working group has developed an on-line tool kit useful in the effort and will develop a consensus training needs program to add to the tool kit.
- CRCPD continues to participate in the National Alliance for Radiation Readiness, which will be meeting in early June of this year.
- The HS/ER-5 Committee on Emergency Response Planning has completed a report on accident assessment capabilities in the states within the EPZ of reactors. This will be discussed with FEMA staff soon and should be available as a resource for states soon.
- The HS/ER-5 Committee are also starting their review of FEMA REP21 and REP22 guidance documents for input on any needed changes. If other states have comments on these documents, Ken Evans, Chair of the Committee, encourages their input to the committee through him.
- The HS/ER-5 Committee is discussing the implementation of the new EPA PAG Manual. Some states are planning to continue use of the Thyroid PAG.
