## **NNSS now accepting summer internship applications**

*More than 70 paid positions open for undergraduate, graduate and doctoral students*

**NORTH LAS VEGAS** – The Nevada National Security Site (NNSS) is currently accepting internship applications from undergraduate, graduate and doctoral students. The Site’s largest contractor, Mission Support and Test Services LLC (MSTS), has more than 70 science, engineering, technology, business and information technology internship positions available this summer.

“Our mission at the NNSS is national security, and we’re looking for the best and the brightest to help continue achieving that mission in the future,” said Mark Martinez, MSTS president.
