FEDERAL FACILITY AGREEMENT AND CONSENT ORDER (FFACO), NOVEMBER 2024 APPENDICES UPDATE

This letter is to distribute the November 2024 version of the FFACO, Revision 50. The revised Appendices III – IV reflect changes to Corrective Action Units (CAUs) and Corrective Action Sites (CASs) that have occurred since the January 2023 revision was released.
