RESPONSE TO THE NEVADA SITE SPECIFIC ADVISORY BOARD (NSSAB)  
RECOMMENDATION FOR ANNUAL NEVADA NATIONAL SECURITY SITE  
ENVIRONMENTAL REPORT (NNSSER) - WORK PLAN ITEM #2

The U.S. Department of Energy (DOE), Environmental Management (EM) Nevada Program appreciates the NSSAB's interest and input during the February 19, 2025 Full Board Meeting for ways that Chapter 11 of the NNSSER could be enhanced (i.e., readability, presentation of information, etc.).

The EM Nevada Program recently submitted input to the 2024 NNSSER and would like to provide the following status updates to Board recommendations for enhancements to Chapter 11 of the NNSS, as found in your letter dated February 26, 2025:

- ***NSSAB recommendation:*** Provide a link to the Federal Facility Agreement and Consent Order (FFACO) in the reference section  
***Status:*** Link to FFACO is now included in reference section
- ***NSSAB recommendation:*** Update the Navarro STEM Grants information  
***Status:*** This information is updated annually
- ***NSSAB recommendation:*** Add a clarification of the terms “closure” and “post-closure” in the context of the FFACO  
***Status:*** Clarifications added to the NNSSER
- ***NSSAB recommendation:*** Strive for consistency in maps used in the NNSSER Summary to match the rest of the document  
***Status:*** Maps were revised to attempt to match the non-EM sections of the NNSSER
- ***NSSAB recommendations:*** Ensure that all locations referenced are included on the maps  
***Status:*** Care was taken to ensure that all referenced locations were included

- ***NSSAB recommendation:*** Make some of the maps larger by splitting up onto multiple pages so the symbols can be delineated and clearly seen  
***Status:*** The current map sizes were unchanged; however, this recommendation will be kept in mind for future submittals
- ***NSSAB recommendation:*** Emphasize EM Nevada Program accomplishments earlier in the chapter  
***Status:*** A new section was added to the beginning of the chapter with accomplishments
