


Environmental Management (EM) Nevada Program Activities Monthly Report to the Nevada Site Specific Advisory Board (NSSAB) September 2025

Waste Disposal and Transportation

- The fiscal year 2025 Transportation Report for the third quarter (April June 2025) can be accessed here.
- Update from previous reports Piketon, OH generator: In August 2024, the Radioactive Waste Acceptance Program (RWAP) issued a Finding regarding prohibited items found in a waste container discovered during Real-Time Radiography. RWAP reviewed and recommended closure, and the EM Nevada Program closed the Finding in June 2025. In August 2025, a related profile was approved by the Waste Acceptance Review Panel (WARP).
- Update from previous reports West Valley, NY generator: In September 2024, RWAP conducted a facility evaluation that resulted in two Findings. The EM Nevada Program received the corrective action plan (CAP) in March 2025 that underwent WARP review. In July 2025, the EM Nevada Program received the closure package and closed the Findings in August 2025.
- Update from previous reports Paducah, KY generator: In November 2024, RWAP conducted a facility evaluation that resulted in one Finding. The EM Nevada Program received the CAP in May 2025 and closure evidence package in August 2025. The EM Nevada Program closed the Finding in August 2025.
- Update from previous reports Idaho Falls, ID generator #2: In July 2025, RWAP conducted a facility evaluation that resulted in no Findings.
- Update from previous reports Aberdeen, MD generator: In July 2025, RWAP conducted a facility evaluation that resulted in no Findings.
- Update from previous reports Erwin, TN generator: In July 2025, RWAP conducted a facility evaluation that resulted in no Findings.
- Update from previous reports Idaho Falls, ID generator #3: In July 2025, RWAP conducted a facility evaluation that is awaiting a final report.
- In the month of August 2025, RWAP conducted one facility evaluation:
 - o West Valley, NY generator: Awaiting a final report.
- In the month of September 2025, RWAP plans to conduct two facility evaluations.

- In the month of August 2025, 50,544 cubic feet of low-level waste (LLW), mixed (MLLW), and classified waste was received for disposal at the NNSS. Data is considered preliminary until internal quality checks are completed.
- In the month of September 2025, approximately 89,429 cubic feet of LLW, MLLW, and classified waste is forecasted for disposal at the NNSS.
- Between October 1, 2024, and the week ending August 31, 2025, 714,405 cubic feet of LLW, MLLW, and classified waste has been received for disposal at the NNSS. Data is considered preliminary until internal quality checks are completed.

Post-Closure Monitoring

• Non-Resource Conservation and Recovery Act (RCRA) Post-Closure Monitoring Sites

The Non-RCRA Post-Closure Monitoring Sites include Corrective Action Sites (CASs) where post-closure inspections and maintenance were performed in accordance with closure requirements. Maintenance and repairs identified during the 2024 annual inspections were completed in calendar year 2025. The 2025 annual inspections have begun and will continue through the end of the calendar year.

Industrial Sites

Corrective Action Unit (CAU) 114, Area 25 Engine Maintenance, Assembly and Disassembly (EMAD) **Facility** CAU 114 comprises three CASs in Area 25 of the NNSS. The Streamlined Approach for Environmental Restoration (SAFER) Plan was approved by the State of Nevada Division of Environmental Protection (NDEP) in June 2021. Preparation of the facility for eventual demolition continued in August 2025.

• CAU 572, Test Cell C (TCC) Ancillary Building and Structures
CAU 572 comprises five CASs in Area 25 of the NNSS. The SAFER Plan was approved by NDEP in April 2021. Demolition activities at the facility continued in August 2025.
